#### PUBLIC PUBLICATION CONTRACT

Sole proprietor Golovina Maryna Mykhailivna, acting on the basis of Certificate of State Registration No 24560170000002135 dated March 21, 2006, Certificates of registration of the subject of publishing in the State Register of publishers, manufacturers and distributors of publishing products No DK 6154 dated April 24, 2018, hereinafter referred to as the Publisher, and citizen (Full Name), hereinafter referred to as the Customer, concluded the present Contract about the following:

## 1. Terminology of Contract

Journal – scientific economical journal Path of Science (eISSN 2413-9009).

Customer – author(s) of a scientific article sent to the journal for its publication, who paid the cost of publishing services.

Publisher - Sole Proprietor Golovina Maryna Mykhailivna.

Other terms, used in the present Contract, correspond with the norms of the current Ukrainian legislation.

## 2. Scope of Contract

2.1. The Publisher undertakes to perform editorial and publication preparation of the article for its publication in the Journal on request of the Customer, and the Customer undertakes to pay to the Publisher for these services under conditions of the present Contract and under conditions of publication in the Journal.

# 3. Rights and responsibilities of the Parties

- 3.1. The Customer shall pay for services specified in Clauses 2.1.
- 3.2. The Publisher undertakes:
- 3.2.1. To provide the Customer with the services specified in Clauses 2.1 of the present Contract in full volume and with proper quality.
- 3.2.2. Not to change the price of the services after the Customer's payment for the services.
  - 3.3. The Publisher has the right:
- 3.3.1. To request from the Customer additional information required for rendering the services specified in Clauses 2.1 of the present Contract.
- 3.3.2. To unilaterally introduce changes into the present Contract in the event of alteration of the current legislation. Moreover, the renewed provisions of the present Contract are not applicable to the relation of the Parties in the part of the services, earlier paid for by the Customer.

# 4. Cost of services and order of payment

4. Cost of services is determined by the Publisher independently in accordance with the "Author Fee" in the Journal, valid at the moment of conclusion of the present Contract.

4.2. The Customer makes the advance payment for the services of the Publisher in the amount of one hundred percent (100%) in accordance with the invoice billed by the Publisher.

### 5. Order of rendering of service

5.1. After performance of the services specified in the Clause 2.1 of the present Contract, the Customer's article is published on the Journal's website.

### 6. Specific conditions

- 6.1. The present Contract is a contract of adhesion in accordance with the Article 634 of the Civil Code of Ukraine and also is an offer in accordance with the Article 641 of the Civil Code of Ukraine, acceptance of which on behalf of the Customer is performed through payment for the services rendered by the Publisher. In the event when the Customer is a third party and not the author(s) of the article, acceptance of the above mentioned offer is performed by this third party as by the present Contract signing party with payment for the services of the Publisher.
- 6.2. In the event of absence of claims of the Customer with respect to the services rendered by the Publisher within the period of one (1) calendar month from the date of publication of the article in the Journal, the services are considered to be accepted by the Customer independently from whether the Customer signed or did not sign a relevant certificate.
- 6.3. Relations between the Customer (third party) and author(s) of the article are subject to settlement between them, without participation of the Publisher.

#### 7. Other conditions

- 7.1. All disputes arising from performance of the present Contract are settled by the Parties through negotiations.
- 7.2. In the event consent of the Parties through negotiations is not achieved, the disputes and controversy are subject to judicial resolution at the place of location of the Publisher.
- 7.3. The Publisher is not responsible for non-performance or improper performance of the conditions of the present Contract in the event of force-majeure circumstances, upon elimination of which the Publisher shall perform its obligations in full volume.
- 7.4. The Parties shall be governed by the current legislation of Ukraine with respect to all issues that are not envisaged by the present Contract.
- 7.5. Place of conclusion of the present Contract is the place of location of the Publisher.
